As in past years you may want to extend your time as the hotel will give you the same discounted rate for the three days before and two days after our Reunion dates.

# C-Troop Grieves at Loss of Old Indian

It was with heavy hearts that four 'Hawks traveled to Indian Bayou, Louisiana on April 8th to attend the funeral of Sgt. Ronald Garrett; a friend, mentor, guardian and cherished member of C Troop's 2nd Platoon. Sgt. Garrett was possibly the most well known individual in the entire Troop, always trying to instruct his charges in ways they would remember. He was famous for his 'Old Indian' tricks, which frequently meant that someone was going to end up in varying degrees of pain. His knowledge of armored cavalry tactics made him an ideal instructor as the 2/1 Cavalry trained at Ft. Hood, Texas prior to their deployment in Vietnam.

Sgt. Garrett served two tours of duty during the Korean Conflict before going to Vietnam with the 2nd of the 1st. He was the holder of the Silver Star, two Bronze Stars and the Purple Heart. He spent 20 years in the Army, retiring in 1970.

He leaves to mourn, his wife of 54 years, Edith (Margie), three sons, Marvin (Becky) Garrett, Ronnie (Kelly) Garrett and Danny (Dana) Garrett along with two daughters, Darlene (Robert) Powell and Margie (Mike) Gabrielle.

Representing C Troop of the 2nd Squadron, 1st Cavalry at his funeral were Merle (Buddy) Lindsey, Tom Schluchter, Jerry Barker and Dennis Scott.

His tour of duty in Vietnam with the 2nd Squadron, 1st Cavalry resulted in the presentation of several decorations including the Vietnam Service Ribbon, the Vietnam Campaign Medal and the Vietnamese Cross of Gallantry.

He is survived by his wife of 51 years, two daughters, Sharon (Clarence) Williams, Linda (Chuck) Dyer and two sons, Jeff (Theresa) Stull and Joey (Stephanie) Stull; as well as his mother, Florence Stull, two sisters, LaDonna Epply and Kathy Mulenberger.

# Headquarters Hotel is a Real Holiday Deal

## *Location, Value And Courtesy*

As stated on page one of this *Bulletin*, much time was spent investigating sites and negotiating with hotels for the 2010 Reunion. The final decision came down to two hotels with the same room rates, one that would also include a \$15 per day parking fee and one that decided they could offer us FREE parking. Guess which one was chosen?

The winner of the contest was the Holiday Inn National Airport located in Arlington, VA.

This is a 280-room facility that offers newly renovated guest rooms, complimentary Wired and Wireless High Speed Internet, a 32-inch high definition, LCD flat screen TV, in-room coffee makers, hairdryers, iron and board, plus refrigerators in many of their rooms.

We have reserved a 75-room block to get us started. Our discounted rate is \$89.00 per night plus taxes, which amount to 10.25% or you can just plan

on \$98.12 per night and free parking in the hotel's on-site lot. This rate is only about \$5 more per night than we paid at the 2000 Reunion in D.C. When you make your reservations, be sure that you identify yourself as part of the 2nd Squadron, 1st Cavalry Association group. Reservations into our room block will begin September 10, 2009. The cut-off date for our group is August 17, 2010.

Reservations may be called in directly to the hotel at 703-684-7200. When we did a site visit, we found the management and staff at this hotel to be very efficient and helpful.

## Getting Around Town

The Holiday Inn Airport offers a free airport shuttle and is located less than one mile from Reagan International Airport.

One of the easiest ways to get around D.C. is by the Metro subway system which is ADA approved. When we were in D.C. in 2000, we found this subway system to be fast, efficient, and easy to use. The Metro's telephone number is 202-637-7000 if you want more information. The Holiday Inn also offers a free shuttle to and from the nearest Metro station which is located about four blocks from the hotel. This shuttle runs every 30 minutes from 6am to midnight. You could also drive your own vehicle to the various sites or take one of the many available tours.
